## BSTP Funding Opportunities for Trainees

In addition to reduced registration fees for individuals working within an “**early career**” environment, the BSTP are able to offer at least one **free** place on each of the Continuing Education Symposiums (CES).

Applications are invited from interested members and non-members of the BSTP. The awarding of funding will be at the discretion of the BSTP Council. Priority will be given to individuals working within an “**early career**” environment, for example, stipendiary students/researchers studying/working within a relevant scientific field, veterinary pathology residents and professional trainee pathologists working towards a professional qualification or gaining more experience within the field of toxicological pathology.

Also, if the successful candidate is not already a member of the BSTP, they will also receive up to 12 months **free** membership of BSTP.



For BSTP Annual Scientific Meetings (ASM), including joint meetings organised by the BSTP, a bursary of up to £500 to help towards the cost of travel and registration at the meeting is available. In addition, if the successful candidate is not already a member of the BSTP, they will also receive at least 12 months free membership of BSTP.

For the 37th Annual Scientific Meeting of the BSTP, a number of free places will be available, plus there are reduced registration fees for individuals working within an “**early career**” environment.

## Trainee Activities

The BSTP website has a dedicated area giving information for pathologists training for examinations in veterinary pathology.

The BSTP Council has a Councillor whose role and responsibility is that of trainee and public engagement strategy.

They are responsible for facilitating relevant training and support to trainees and junior members and promoting toxicological pathology as a career:

- To liaise with veterinary schools and the wider veterinary profession to promote toxicological pathology as career.
- To signpost opportunities to experience the work of a toxicological pathologist
- To liaise with the trainee representative in the Educational Subcommittee to provide support for career development and training

There is also a trainee representative who sits on the Education Sub-committee and is responsible for maintaining contact with members of the BSTP who are preparing for FRCPath examinations, or the European or American Board exams.



The trainee page offers information on available training; links to Examination boards; opportunities for residents; and a comprehensive reading list.

The trainee representative will also organise mock exam days. In the past, these have been held at locations around the UK and have given trainees the opportunity to practice the techniques of slide description under exam conditions, and to get feedback from past and present Royal College examiners.

# BSTP Membership

The BSTP has a single category of “Ordinary Membership”.

In the constitution Ordinary Membership will mean:

“Individuals applying for Ordinary Membership should normally be actively engaged in toxicological or experimental pathology and their experience and training must be acceptable to Council. Also, individuals who are recognised by Council to have an active interest in or are actively supporting toxicological and experimental pathology, and whose experience and training are acceptable to Council, may apply for Ordinary Membership of the Society. Applications when submitted should include a curriculum vitae and any other relevant supporting material together with supporting letters from two Members of the Society.

*Ordinary Members shall have all the privileges of Membership, including the right to vote and hold office, and they shall pay an annual fee of £60.”*
